What is the purpose of this update?

This document tells you how the Russell Investments Hedged Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

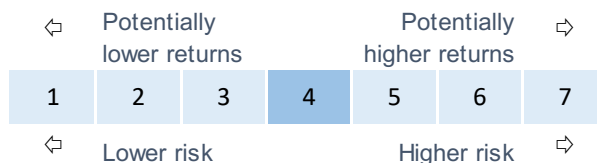
Objective: to provide a total return, before costs and tax, higher than the Russell Global Large Cap NZ Hedged – Net Index over the long term (3 years plus).

Strategy: the underlying investment exposure is predominantly to a broad range of international shares listed on stock exchanges in developed markets as well as emerging international markets. Derivatives may be used to obtain or reduce exposure to securities and markets, to implement investment strategies and to manage risk. The fund targets a position of being fully hedged back to New Zealand Dollars. Due to active currency management by the underlying managers, there will generally be some foreign currency exposure.

What are the risks of investing?

Risk indicator for the Russell Investments Hedged Global Shares Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

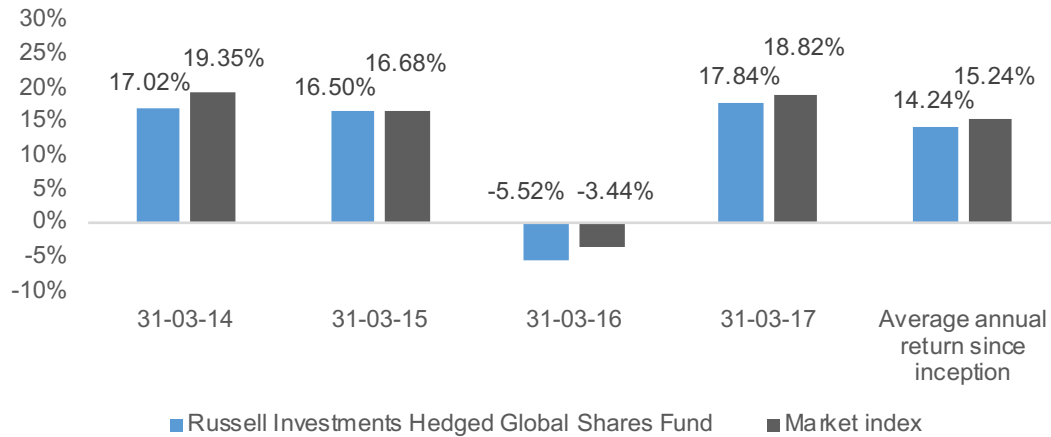

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2017.

What fees are investors charged?

Example of how this applies to an investor

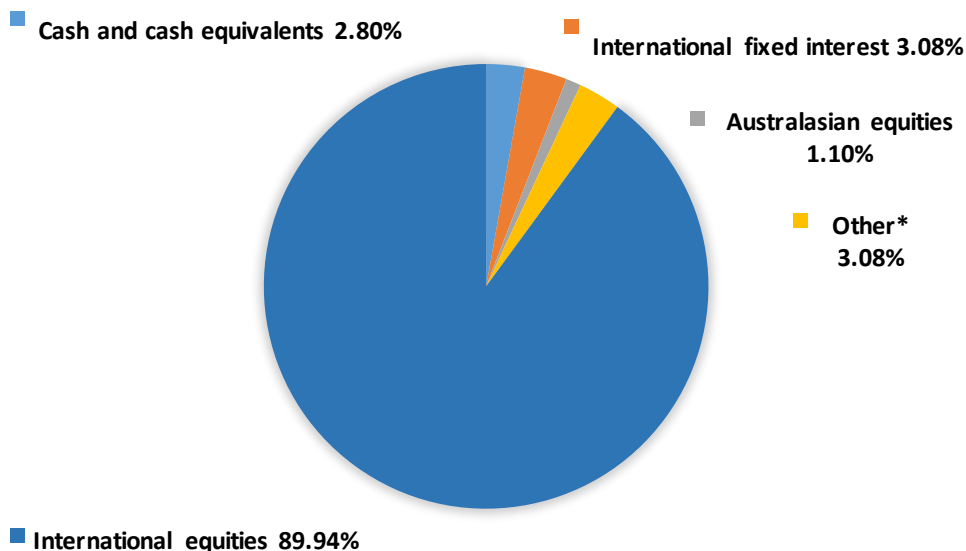
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,902 (that is 19.02% of his initial \$10,000). This gives Anthony a total return after tax of \$1,784 for the year.

This shows the types of assets that the fund invests in.

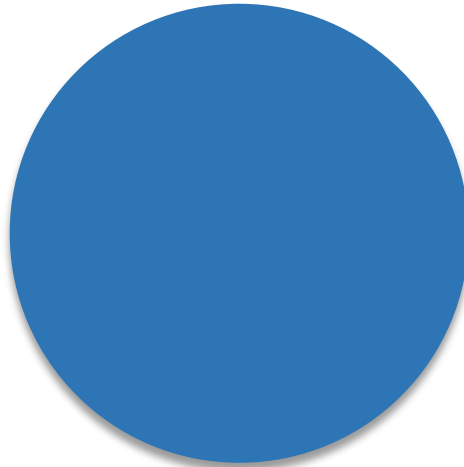
Actual investment mix

- ¹ These returns are for the year to 31 December 2017.
- ² The bar chart shows fund returns after deducting fees and tax. Tax is deducted at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
- ³ We have taken the underlying fund's fees and costs data from the underlying fund's financial statements which are for the year to 30 June 2017. In this fund update, we have estimated the underlying fund's fees and costs for the year to 31 March 2017 on the assumption they will be the same as that disclosed in those financial statements.
- ⁴ We have reported the US as the country for the forward currency contract in the Top 10 Investments table, as the US dollar is the base currency being hedged by this contract.
