1. Details of scheme

- Name: Russell Investment Funds ('scheme')
- Type: Managed Investment Scheme
- Manager: Implemented Investment Solutions Limited ('we', 'us', 'our')
- Supervisor: Public Trust
- Product Disclosure Statement ('PDS'): The latest PDS is dated 5 June 2020. The offer is open for applications.
- Fund Updates: The latest fund update for the Scheme was dated 24 July 2020 and was for the period ended 30 June 2020.
